What hazard have you identified? What are the risks from it?	Who is at risk?	How are the risks already controlled? What extra controls are needed?	What has changed that needs to be thought about and controlled?
<p><b>A hazard</b> is something that may cause harm or damage. <b>The risk</b> is the harm that may occur from the hazard.</p>	For example: young people, adult volunteers, visitors	<b>Controls</b> are ways of making the activity safer by removing or reducing the risk. For example, you may use a different piece of equipment or you might change the way you do the activity.	Keep <b>checking</b> throughout the activity in case you need to change what you're doing or even <b>stop</b> the activity.
Over Crowding	Everyone	Limited to 12 participants per session at any one time.	
Operator Competence		Instructors (site of other) must hold either of the qualifications Rope Leader / Supervisor, SPA/CWA, MIA, GGUK level 1 & Scout Assosiation qualification.	Duty Warden to ensure Qualified Instructor available.
Equipment Failure	Everyone	Equipment checked at begining and end of every sesion and rope usage logged on the Rope log document in the climbing wall. If imperfections detected Item removed and replaced. Annual Inspections on all equipment.	Record of Inspections
Failure or Lack of Lighting	Visual Inspection prior to use, Safety rope in use at all times, Load Tested	Activity cancelled, do not run in dark. Risk Removed.	
Incorrectly Fitted Harness & Helmet.	Participants	All equipment fitted by a competent person and checked by a qualified instructor.	Inspection by site staff prior to use, Report issues to Manager
Person / Material Falling / Struck by Object	Leaders/Participants	Helmets must worn at all times within the Climbing area.	
Anchor Failure	Everyone	Visual Inspection prior to use, Safety rope in use at all times, Load Tested

## Risk assessment

Ladder Falling	Instructor / Participant	Ladder is fully secured to tower, visual/safety inspections carried out insurance inspection certification carried out annually.	
Falling off ladder	Instructor / Participant	Instruction provided on how to ascend/descend ladders. Only one participant allowed on ladder at a time. Participants belayed via self belay safety fall arrest device.	
Over Crowding & Fall from Tower	Instructor / Participant	Max 5 persons on platform at any one time. Safety Barriers in place on edge of wall. Instructor must be clipped in. Participants clipped to a safety strap and transferred to safety line for belaying.	Instructor to monitor.
Contact with wall during descent	Participants	Correct technique described by instructor. Long hair and scarves tied back or removed.	
Slips trips and falls	Everyone	Site Knowledge, designated path to facility.
